Procedure to connect JR-SHIKOKU_Station_Wi-Fi

【Wireless LAN info】

- **SSID : JR-SHIKOKU_Station_Wi-Fi**
- **IP Address: Acquired automatically**
- **DNS Address : Acquired Automatically**
- **Encryption : None**

Note :

The device need to turn acquire IP address and DNS address automatically on.
If IP address or DNS address are already set, it is recommended that you make note of the settings.

System requirements

- ① **Android (Android 4.0 or later)**
- ② **iPhone/iPod touch/iPad (iOS 5.0 or later)**
- ③ **Windows (Windows 7 or later)**
- ④ **Mac (Mac OS X or later)**

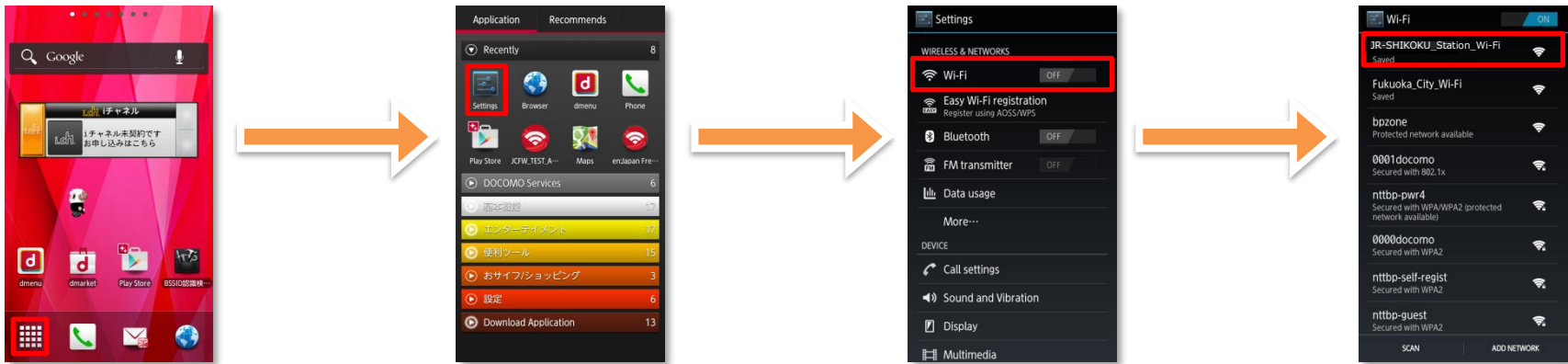
Note:

【Android】 Procedure to connect (e.g.: Xperia)

- ① Tap the "Application" icon.
- ② Tap the "Settings" icon.
- ③ Tap "Wi-Fi".
- ④ A list of Wi-Fi networks will appear. Select "JR-SHIKOKU_Station_Wi-Fi".



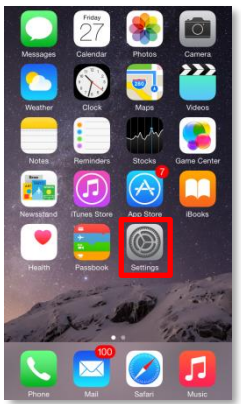
- ⑤ Tap "Connect".

[iOS] Procedure to connect (e.g.: iOS 8.0)

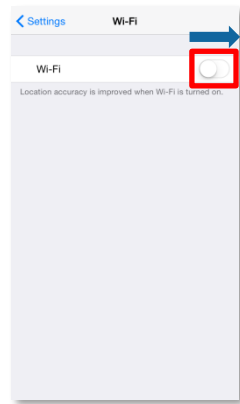
① Tap the "Settings" icon.



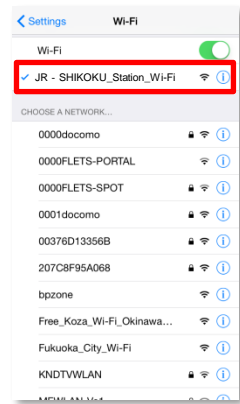
② Tap "Wi-Fi".

④ A list of Wi-Fi networks will appear. Select "JR-SHIKOKU_Station_Wi-Fi".



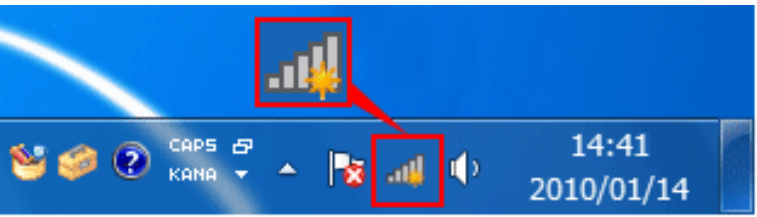
⑥ When the screen below appears, connection is complete.

【Windows】 Procedure to connect (e.g. : Windows7)

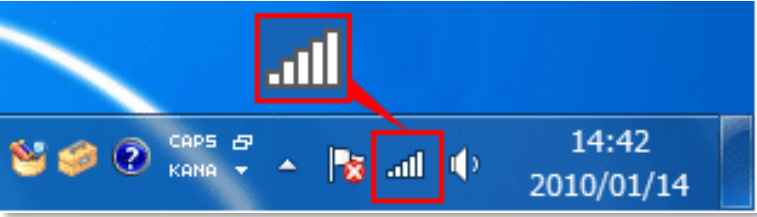
① Click on the network icon in the lower right corner of the screen

④ launch the Browser (Internet Explorer or Google Chrome) .



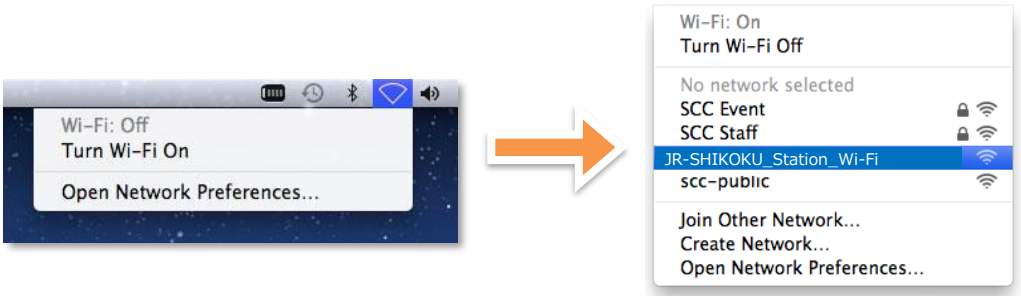

③ Enter your e-mail address, Then tap "Confirm"

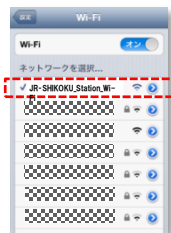

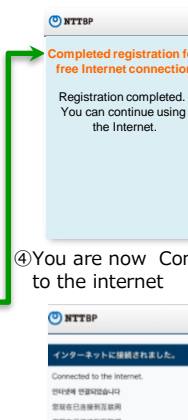

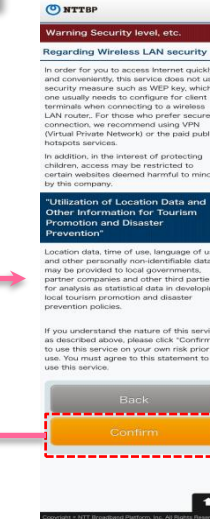

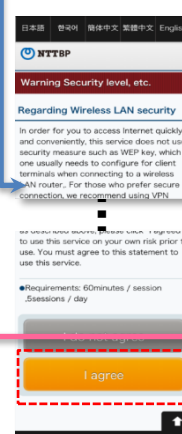
